In the event of fraudulent use of the credentials to access the virtual meeting, SIPKES s.r.o. as IFSA-EUSFLAT 2021 organizer reserves the right to charge the participant a penalty equivalent to the number of individuals accessing the virtual meeting.

Registration cancellation and modification

The registration fee will be refunded (with a deduction of 10 % to cover the handling costs) when the participation is withdrawn in a written form by e-mail: at ifsa-eusflat_2021@sipkes.sk before **August 1, 2021**. No refund will be granted after this date.
